## **NA Selective Supplement**

**FD130** 

An antibiotic supplement recommended for the selective isolation of *Pseudomonas aeruginosa* from clinical specimens.

## Composition

Per vial sufficient for 1000 ml medium

\*Ingredients Concentration
Nalidixic acid 15mg

#### **Directions:**

Rehydrate the content of 1 vial aseptically with 5 ml of sterile distilled water. Mix well and aseptically add to 1000 ml of sterile, molten, cooled (45-50°C) Cetrimide Agar Base M024 / Cetrimide HiVeg<sup>TM</sup> Agar Base MV024 / Cetrimide Agar Base, Granulated GM024 / Cetrimide HiCynth<sup>TM</sup> Agar Base MCD024 / Cetrimide Agar Base (w 1.3% Agar) M1742. Mix well and pour into sterile petri plates.

## Type of specimen

Clinical samples: pus, blood, urine, tissue, etc.

### **Specimen Collection and Handling**

For clinical samples follow appropriate techniques for handling specimens as per established guidelines (1,2). After use, contaminated materials must be sterilized by autoclaving before discarding.

## **Warning & Precautions**

In Vitro diagnostic use only. For professional use only. Read the label before opening the container. Wear protective gloves/protective clothing/eye protection/face protection. Follow good microbiological lab practices while handling specimens and culture. Standard precautions as per established guidelines should be followed while handling clinical specimens. #### **Storage and Shelf Life**

Store at 2 - 8°C. Use before expiry date on the label.

User must ensure safe disposal by autoclaving and/or incineration of used or unusable preparations of this product. Follow established laboratory procedures in disposing of infectious materials and material that comes into contact with clinical sample must be decontaminated and disposed of in accordance with current laboratory techniques (1,2).
