Recommended for isolation of non-typhi *Salmonella*.

Composition

4.6 ml of supplement is sufficient for 1000 ml medium

Ingredients

(40 ml per vial contains Tergitol 4 - 27%)

Tergitol 4

Distilled water

Concentration

10.800g

Directions:

Warm up XLT4 Supplement to room temperature and add 4.6ml to 1000 ml of XLT4 Agar Base [M1147](#)/ XLT4 HiVeg™ Agar Base [MV1147](#). Heat to boiling to dissolve the medium completely. Avoid overheating. DO NOT AUTOCLAVE. Mix well and pour into sterile petri plates.

Type of specimen

Clinical- stool, abscess

Specimen Collection and Handling

For clinical samples follow appropriate techniques for handling specimens as per established guidelines (1,2). After use, contaminated materials must be sterilized by autoclaving before discarding.

Warning & Precautions

Store at 2 - 8°C. Use before expiry date on the label.

Follow established laboratory procedures in disposing of infectious materials and material that comes into contact with clinical sample must be decontaminated and disposed of in accordance with current laboratory techniques (1,2).

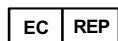

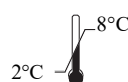
