An antibiotic supplement used for detection of Clostridium perfringens from pharmaceutical products.

Composition

Per vial sufficient for 1000 ml medium

*Ingredients Concentration

Gentamicin 20mg

Directions:

Rehydrate the content of 1vial aseptically with 5 ml sterile distilled water. Mix well and aseptically add it to 1000 ml sterile, molten, cooled (45-50°C) Columbia Agar MH144/ Columbia Agar, Granulated GMH144. Mix well and pour into sterile Petri plates.

Specimen Collection and Handling

For Food samples follow appropriate techniques for handling specimens as per established guidelines (1). After use, contaminated materials must be sterilized by autoclaving before discarding.
