Introduction:

Blocking Buffer (3% BSA in 1X PBS) is made of high-quality BSA that is useful for saturating excess protein-binding sites on membranes and microplates in immunoassays. A good blocking buffer for a specific experiment will bind to all potential sites of nonspecific interaction, eliminating background without altering or obscuring the epitope for antibody binding.

Description:

The blocking buffer should improve the sensitivity of the assay by reducing background interference and improving the signal-to-noise ratio. Blocking Buffer (3% BSA in 1X PBS) is a ready-to-use solution which can be used for blocking steps in Western blot, ELISA, IHC and nucleic acid detection methods.

Application:

Blocking Buffer with BSA is usually more effective than nonfat milk blocking buffers for biotin-avidin systems because it contains a single purified protein that is devoid endogenous biotin. The purpose of the blocking step in an assay is to improve assay sensitivity by reducing background interference.

Procedure for Blocking:

1. Add Blocking Buffer (3% BSA in 1X PBS) to the well of microplate, blotting membrane or immunohistochemical slide.
2. Incubate for 30 minutes to 2 hours at room temperature or at 37°C or as per the specific requirement.
3. Continue protocol as per your specific application.
